From *CalvertHealth Medical Center*, take Route 4 South. Turn right onto Route 231 towards Hughesville. Follow through the traffic circles and take Route 5 South to Charlotte Hall. Take a left onto Golden Beach Road and follow until you see the Anchor Treatment Center on the right.

From *University of Maryland-Charles Regional Medical Center*, take Route 6 South until Charlotte Hall. Take a left onto Route 5 North. Take a right onto Golden Beach Road and follow until you see the Anchor Treatment Center on the right.

From *MedStar St. Mary's Hospital*, take Route 5 North to Charlotte Hall. Take a right onto Golden Beach Road and follow until you see the Anchor Treatment Center on the right.

KATHLEEN O. O'BRIEN, Ph.D., Chief Executive Officer, Walden Behavioral Health



Kathleen O. O'Brien, Ph.D., is CEO of Walden Behavioral Health a premier behavioral health organization serving Southern Maryland. She earned her bachelor's and master's degrees from the University of Maryland, and her doctorate in clinical psychology from LaSalle University.

Dr. O'Brien began her long association with Walden in 1973, serving as the clinical director from 1978 to 1990, when she became the executive director. Her commitment and dedication have been a driving force in the development and expansion of a multi-service behavioral health organization

that is respected throughout the state and has received national recognition.

Dr. O'Brien plays a prominent role in her community and throughout the state where she is a strong advocate for quality services for children and their families. She serves on numerous boards and commissions. She is a gubernatorial appointee on the State Drug and Alcohol Council, the Opiate Overdose Council, the Health and Human Services Referral Board, and the State Victim Services Board. She serves on the Maryland Executive Council of AARP. Dr. O'Brien is the president-elect of the MD Association of Addiction Directors. (MADC)

Additional local and state boards include: Healthshare, Camp Maria Board, the Maryland Juvenile Justice Coalition, the MD Network Against Domestic Violence, and the MD Coalition Against Sexual Assault. Dr. O'Brien has also served as a member of the National Council on Accreditation, the Child Welfare League of America Steering Committee and a subcommittee of the White House Drug Policy Council.

Dr. O'Brien is the founding chairperson of the St. Mary's Family Violence Coordinating Council. She petitioned the county to establish this council after several domestic violence deaths rocked the community.

Dr. O'Brien is a Weinberg Fellow and was a member of Leadership Maryland Class of 2008. Dr. O'Brien was the 2008 recipient of the National Sunshine Peace Award, from the Buffet foundation, in recognition of her outstanding work on behalf of domestic violence victims. In 2010, she received the Social Impact Award from the Weinberg Foundation for her efforts to assist the homeless.

During the summer of 2013, Dr. O'Brien participated in the Harvard Business School Nonprofit Leadership Institute where she had the opportunity to work with nonprofit and NGO leaders from around the world.

Dr. O'Brien has been married to her husband, Paul, for 39 years and they are the proud parents of six highly accomplished young adult children.

MIKE ROBBINS, Senior Vice President, Maryland Hospital Association



Mike Robbins leads Maryland Hospital Association's (MHA) financial and regulatory advocacy efforts for Maryland's hospitals with the Health Services Cost Review Commission, including continuing efforts to modernize Maryland's all-payor Medicare waiver. He also provides support to MHA's government relations team on all financial matters during the state's legislative session. Prior to coming to MHA in 2009, Robbins served as the vice president for financial policy at the West Virginia Hospital Association (WVHA).

**SHARON MURPHY**, Director, Veterans Home Program, Charlotte Hall Veteran's Home, Maryland Department of Veterans Affairs



Sharon Murphy was born and raised in Charles County, Maryland. Murphy began her state career in July 1984 when she joined the small staff at Charlotte Hall Veterans Home as the assistant to the commandant. In the over 30 years at Charlotte Hall, she has been an integral part in the operation and expansion of the home, watching it grow from four residents and 20 staff, to the current occupancy of 417 residents and over 500 employees. Murphy's dedication to the home and its residents culminated in June, 2008, when she accepted the position of director, Veterans Home Program, serving as the contract manager for the State of Maryland Veterans Home Operations. The day-to-day operation of

the home is the responsibility of the contractor, HMR of Maryland.

As director, Murphy is responsible for monitoring the operation of the facility to ensure contract compliance with federal, state, and local regulations and to provide oversight of resident care, fiscal management and support services. Murphy represents the MD Department of Veterans Affairs in contacts with federal, state, and local elected officials. She is responsible for preparing and administering the home's annual operating budget and capital improvement projects. She serves as the on-site advocate for residents and responds to inquiries by residents, family, and elected officials. Murphy is actively involved in the marketing of the home and maintains liaisons with veteran and community organizations locally and statewide to promote awareness of Charlotte Hall Veterans Home and the services it provides.

#### WILLIAM TRAVIS RAHILL, Operations Manager, Operation Tohidu



Sergeant First Class Travis Rahill was born on February 23, 1973 in Bethesda, Maryland. He grew up in Indian Head, Maryland and graduated from Lackey High School in 1991. He enlisted in the United States Marine Corps on December 8, 1992 as a 0331, machine gunner. Rahill attended boot camp at Parris Island, South Carolina and Advanced Individual Training at Camp Geiger, North Carolina. Rahill was honorably discharged from the Marine Corps as a lance corporal on December 7, 1996. He then enlisted in the US Army as an 11B on July 2, 1997. He is married to the former Valerie

Hodge of La Plata, Maryland. They have two children, Katherine, age 18 and Thomas, age 17.

Rahill's military assignments include Camp Lejeune, North Carolina where he was assigned to the 3<sup>rd</sup> Battalion, 6<sup>th</sup> Marines where he was deployed to Mogadishu, Somalia, Haiti, Guantanamo Bay, and Okinawa, Japan. Rahill's first assignment in the US Army was to the 2<sup>nd</sup> Battalion, 27<sup>th</sup> Infantry at Schofield Barracks, Hawaii where he served as a rifleman, machine gunner, radio telephone operator and team leader. His next assignment was to the 2<sup>nd</sup> Battalion, 187<sup>th</sup> Infantry at Fort Campbell, Kentucky where he served as a team leader and squad leader. Rahill next served with the 3<sup>rd</sup>

Battalion, 11th Infantry (OCS) which is the Officer Candidate School at Fort Benning, Georgia where he served as a TAC NCO. After one year there, he was reassigned to Korea, where he served with the 1st Battalion, 506th Infantry "Currahees". He served as a squad leader in the battalion's Scout Platoon. After 14 months in Korea, the Currahees were deployed to Habbinyah, Iraq for a one-year tour. From Iraq, the battalion was re-deployed to Fort Carson, Colorado. Upon arriving in Fort Carson, the battalion was re-designated the 2nd Battalion, 12th Infantry and Rahill assumed responsibility for 1st Platoon, Baker Company as the platoon sergeant. After a one-year refit, the battalion was again deployed to Iraq. Upon arriving in Iraq, Rahill was assigned to the battalion's S-2 Section where he served as the section sergeant. After a 15-month tour in Baghdad, Iraq, the battalion returned to Fort Carson. Rahill was then assigned to the Albany Recruiting Battalion in the Danielson, Connecticut Recruiting Station. While there, he was the Top Regular Army Recruiter for the battalion in FY 2009. After completing three years in recruiting, Rahill was assigned to the 3rd BCT, 1st Armored Division in Fort Bliss, Texas where he deployed to Afghanistan as a member of the Security Force Advisory Team. Rahill was then assigned to Fort Meade, Maryland as a member of First Army (East) and served in many positions including the division battle captain. He retired on July 31, 2015 after 22 years of service.

Dr. Dianna E. Abney is the health officer for the Charles County Department of Health. She is the medical director for the Child Abuse & Neglect Prevention Program at the Charles County Department of Health. She has practiced pediatrics in Waldorf for over twenty years and continues to see patients in her private practice. Dr. Abney is very active within the community and serves or has served on several boards. She has privileges at the University of Maryland Charles Regional Medical Center and MedStar Southern Maryland Hospital Center, and has served as chairman of pediatrics for both of these hospitals. She is a member of MedChi--the Maryland state medical society and is

the immediate past president of the Charles County Medical Society. Dr. Abney is a co-chair of NMAPedsNet—a practice based research network that is a part of the pediatric section of the National Medical Association. Dr. Abney is also a

member of PROS, the practice based research network of the American Academy of Pediatrics. She is the coordinator for PROS in Maryland. Her research interests include prevention of childhood obesity, treatment and prevention of child abuse, and decreasing healthcare disparities.

Dr. Abney received her undergraduate degree at the Massachusetts Institute of Technology and her medical degree from Tulane University School of Medicine. She completed her residency at Howard University Hospital in Washington, DC. She is a member of the American Academy of Pediatrics, the National Medical Association, the American Medical Association, MedChi, the Maryland state medical society, the Maryland Chapter of the American Academy of Pediatrics, and the Montgomery/ Prince George's Pediatric Society. She is a charter member of the Central Southern Maryland Pediatric Society. She served on the board of the Children's National Hospital and the board of Children's National Health Network (president). She is currently on the Children's National Emeritus board.

Dr. Abney is married to Dr. Sylvester J Gates, Jr. who is a University System Regents Professor and the John Toll Professor of Physics at the University of Maryland in College Park and who recently was awarded the National Medal of Science. They are the parents of twins—Delilah and Sylvester, III., who are both students at University of Maryland—College Park.

#### MEENAKSHI BREWSTER, M.D., St. Mary's County Health Officer

Appointed by the State of Maryland Secretary of Health upon recommendation of the St. Mary's County Commissioners, the St. Mary's County health officer directs the St. Mary's County Health Department and serves as the state designated public health leader for the county. The health officer oversees the department, provides medical guidance in public health decision-making, and represents the county and health department on a variety of local, state, and national councils and committees addressing health.

Dr. Meenakshi Brewster began in her role as the St. Mary's County health officer in December 2012. As health officer for the St. Mary's County Health Department, Dr. Brewster directs activities of the local health department and works with community partners to address population level health issues in St. Mary's County, Maryland. Prior to her current role, she served as the medical director for the Health and Human Services Commission at the Indiana State Department of Health and as the chronic disease director for the state, overseeing a variety of efforts to address statewide public health concerns. Her previous work experience also includes appointment as assistant professor of clinical family medicine at the Indiana University School of Medicine, where she taught medical students, primary care residents, and sports medicine fellows while providing clinical care to patients of all ages and backgrounds.

Dr. Brewster is a public health trained physician, and board certified in the clinical specialties of family medicine and sports medicine. In addition to outpatient and inpatient clinical primary care, she has served as a team physician for different levels of athletics, and provided sports medicine coverage for a variety of athletic events. Her research, presentation, and publication activities cover topics relevant to public health, primary care, and sports medicine. She has a strong interest in wellness, health promotion, and evidence-based public health action.

Dr. Brewster earned a Bachelor of Science in biology, Master of Public Health, and Doctor of Medicine from the University of Miami. She grew up in central Pennsylvania, and lived in Florida and Indiana prior to moving with her family to St. Mary's County, Maryland.

#### DR. REBECCA BRIDGETT LSM'14, County Administrator, St. Mary's County



Dr. Rebecca Bridgett serves as the county administrator for St. Mary's County. She was appointed to the position in April 2013.

Dr. Bridgett brings over a decade of experience in public administration to St. Mary's County serving in a variety of executive level positions in local and state government. Between 2009 and 2012, she served as county administrator for Charles County where she was responsible for a \$235 million operating budget and a \$191 million capital improvement budget. Most recently she

served as a cting director of human resources for the Charles County Sheriff's Office. There she administered policies relating to all phases of human resource activities.

Dr. Bridgett also served as director of the Charles County Department of Social Services, Department of Human Resources, for over five years. In that capacity, she led daily operations for county human service programs for vulnerable adults and children. During her tenure with the Maryland Department of Human Resources, she served as the acting executive director of the Social Services Administration. There she reported regularly to the legislature on key initiatives and was a liaison between central operations and local departments of social service child welfare programs.

Education has played a pivotal role in Dr. Bridgett's career. She served as chair and a member of the Charles County School Board where she developed policy for public school students and was responsible for a \$200 million budget.

Other key career accomplishments include director of the Charles County Human Services Partnership and a crisis outreach worker with the Center for Children in La Plata, Maryland.

Dr. Bridgett holds a Doctor of Education from NOVA Southeastern University, a master's degree in special education from Appalachian State University, and a Bachelor of Arts in English communication from Campbell University.

#### TONY JONES LSM'16, Public Information Officer, St. Mary's County Government



Tony Jones has served as the public information officer for St. Mary's County Government since September, 2011. Serving as the face and voice of county government, Jones has produced and hosted a number of videos, including the annual State of the County video report, is the emcee for various public events including the quadrennial Oath of Office ceremony for newly elected county officials and the annual Fire Rescue Appreciation Day picnic. He moderates several county commissioner events including public forums and hearings.

Jones came to St. Mary's from North Carolina with extensive experience in federal and state government communications and broadcast journalism. Previously, he served as a writer/editor for the Federal Emergency Management Agency (FEMA) in the aftermath of storms and tornadoes which affected North Carolina in April, 2011. There he wrote and edited a variety of items, including news releases, media advisories and organizational reports. Jones also worked for the U.S. Census Bureau as a media specialist. There he served as North Carolina spokesman for the 2010 Census, conducted various media relations activities, coordinated census promotions and conducted media training for census employees. His broadcast journalism career spanned more than a dozen years where he was an anchor, reporter, photographer and producer in TV markets including New York City, Baton Rouge, Raleigh, and Mobile. Events Jones covered include the 2007 march on Jena, Louisiana and the aftermath of hurricane Katrina in 2005—2007. He also reported live for CNN during hurricane Isabel in 2003. The New York City native has also served as an adjunct instructor with New York University's School of Continuing and Professional Studies' TV News Production workshop.

Jones earned his Bachelor of Fine Arts in communication arts from the New York Institute of Technology. He is an avid sports fan, enjoys traveling and music.
