

**From La Plata:** Take MD-488 E/ La Plata Road to MD-5. Turn right on MD-5 S/ Leonardtown Road. Use the right lane to take the MD-231 ramp to Prince Frederick/ Hughesville. Continue to follow MD-231 E. Turn left onto Stafford Road.

**From Lexington Park:** Take MD-235 N/ Three Notch Road to MD-4. Turn right on MD-4 N/ Patuxent Beach Road. Continue on MD-4 N/ Solomons Island Road. Turn left onto MD-231/ W. Hallowing Point Road. Turn right onto Stafford Road.

**GERALD GARDINER**, **JR. LSM'15**, *Emergency Management Manager*, *St. Mary's County Emergency Services & Technology* 



Gerald Gardiner Jr. is the emergency management manager for Emergency Services, St. Mary's County government. He joined county government in 2009 as the emergency planner until being selected as the emergency management manager in 2011. In 2016, he received his certification in the Maryland Professional Emergency Management Program. As the emergency management manager, Gardiner is responsible for planning and direct disaster response or crisis management activities, providing disaster preparedness training, and preparing emergency plans and procedures for natural or manmade disasters.

He has been a member of the Leonardtown Volunteer Fire Department for 33 years and is a lifetime member. He has served on many committees and boards, performing the roles of secretary, treasurer, lieutenant, captain and chief for seven years.

Gardiner attended Leadership Southern Maryland in 2015.

JACQUELINE "JACKIE" VAUGHAN LSM'13, Director, Calvert County Department of Public Safety



Jacqueline "Jackie" Vaughan has been employed by Calvert County government since November, 1982. Her time with Calvert County, in addition to two years of prior experience working for the Maryland State Police, totals 37 years of related experience managing, supervising, directing, and guiding subordinates within the Public Safety Department independently.

In her capacity as director of the Calvert County Department of Public Safety, Vaughan has fulfilled a myriad of duties. She served as project manager representing Calvert County in replacing the Public

Safety 800 MHz digital radio communications system, the largest contract Calvert County has awarded. She was recently assigned the duties of overseeing the new Linda L. Kelley Animal Shelter and Calvert County Animal Control.

She is a graduate of Leadership Southern Maryland's Class of 2013, "The Best Class Ever".

#### BILL SMITH, Coordinator, Charles County Fire/EMS



Bill Smith is a 46-year veteran of the Maryland Fire/EMS service. He joined the volunteer fire service in April 1974 in Prince George's County, Maryland. After graduation from high school, he served three years in the U.S. Army as a military policeman. Upon completion of his tour of duty, Smith continued serving citizens of Prince George's County and St. Mary's County. During his time serving the citizens in Maryland, Smith has completed hundreds of hours of training from basic fire school to emergency medical technician and many leadership classes including recruitment and retention.

Smith was hired in 2010 to begin a "recruitment and retention" program for St. Mary's County resulting from the county's effort in obtaining a four-year grant for a Staffing for Adequate Fire and Emergency Response Program from the Federal Emergency Management Administration. This program was unique in being the first program at the county level that invited complete collaboration and commitment from all volunteer departments across the county. During the third year of the program, the board of County Commissioners recognized the need for a full time county employee and the recruitment coordinator's position became a full time position.

Smith has since moved on to Charles County where he enjoys working in the public safety field as the Charles County Fire/EMS coordinator. Some of his duties include: daily communications with the 17 Fire and EMS departments, interactions with county government officials, maintaining "tax dollar escrow accounts", recruitment/retention events, and responding to all newsworthy events across the county as the public information officer.

#### KELLY BELL, Recruitment and Retention Coordinator, St. Mary's County



Kelly Bell is the recruitment and retention coordinator for St. Mary's County government. In this role, Bell manages recruitment and retention activities for the volunteer Fire and EMS departments in St. Mary's County.

Before joining St. Mary's County government in 2014, Bell worked for ten years in various roles, for a variety of organizations including St. Mary's Hospital, Southern Maryland Community Network, and Tri-County Council of Southern Maryland.

While employed full-time, Bell joined Lexington Park Volunteer Rescue Squad in January 2010. She earned her EMT-B certification in May 2010. She continues to volunteer at the rescue squad and has served in various leadership roles including lieutenant and field training coach (FTC 2).

Bell majored in psychology at St. Mary's College of Maryland. She has completed various continuing education courses focusing on recruitment, retention, incident command, and emergency medical services.

#### WAYNE HARDESTY, Assistant Coordinator, Fire-Rescue- EMS Division, Calvert County



Wayne Hardesty has been in the Calvert County Volunteer Fire service for 38 years. Presently, as a member with the Prince Frederick Volunteer Fire Department, Hardesty has held many positions to include chief of the department.

Hardesty is retired from the Calvert County Detention Center and is currently employed with Calvert County government as the assistant coordinator for the Fire-Rescue- EMS Division.

#### CHRIS STRONG, Meteorologist, National Weather Service

Chris Strong is a meteorologist with our National Weather Service's local forecast office. His forecast office serves all of the Washington D.C. and Baltimore metro areas. As his office's outreach leader, Strong is in charge of outreach and networking for his office, and ensures that the National Weather Service's forecasts and weather warnings are received - and reacted to - when dangerous weather threatens.

Strong caught the weather bug at a young age and it has stuck with him ever since. Returning to his roots in the Baltimore-Washington, D.C. area after receiving a meteorology degree at Penn State, Strong was hired at the NWS forecast office in Sterling, Virginia in 1993. As the warning coordination meteorologist since 2007, Strong is now a public face for the agency in the capital region, where millions of people, including those in the federal government, rely on accurate weather forecasts on a daily basis.

Although he still fills in for colleagues making the day-to- day predictions when needed, his current position has allowed Strong to get out from behind the computer more and engage with the public, from testifying before government committees to giving presentations to school children.

#### MAJOR T.D. REECE, Administrator, Calvert County Detention Center

Major T.D. Reece, administrator for the Calvert County Detention Center, began his career in corrections in 1984 with the Charles County Sheriff's Office Corrections Division. He served twenty-one plus years with the Charles County Corrections Division, retiring in January of 2006 at the rank of captain, commander of the Custody and Security Division. During his tenure with Charles County, he held many positions within the division across a wide spectrum of responsibilities.

Following his short retirement (one weekend), Captain Reece accepted the position as deputy administrator for the Calvert County Detention Center, a position he held from 2006 to 2011. Captain Reece was promoted to the rank of major at his current position in January, 2011.

#### ALFRED JEFFERY, Division Chief, Emergency Management, Calvert County



Alfred B. Jeffery III, division chief of emergency management, joined county government in 2012 as an emergency planner. He served as the emergency management specialist until being selected as the division chief and the governor's appointed local emergency management director in April of 2016.

Prior to joining Calvert County government, Jeffery worked for the District of Columbia Fire Department. During his 30 plus year career with the department, he served in many positions and roles such as battalion fire chief in the department's Special Operations and Homeland Security

Division, deputy fire chief of the Risk Management Division, and training director for the department. Jeffery was promoted in 2007 to the rank of assistant fire chief overseeing and leading the administrative divisions of the department that included human resources, professional development, training academy, fleet maintenance, fire prevention and investigations, facilities maintenance, and budget and finance.

Jeffery maintains membership in the International Association of Firefighters, International Association of Fire Chiefs, National Fire Protection Association, International Association of Emergency Managers, and Maryland Emergency Management Association.
